### Moving Current / NEWGrounds Choreographic Residency At the Florida Dance Festival

#### **Application Deadline: April 30, 2017 – Notification May 9<sup>th</sup>**

---

This 9 day residency at the Florida Dance Festival is sponsored by Moving Current and the Florida Dance Association. As the *Choreographer in Residence*, artists receive on campus housing, rehearsal space, mentoring, classes at the festival, and a full public performance of their work. Choreographers are selected by a panel of dance professionals based on the artistic excellence of the work samples submitted. If you are accepted there is a fee of \$250, paid by May 31.

**Eligibility:** The residency is open to established and emerging Choreographers that have been working at a professional level for a minimum of three years. All genres of dance are welcome.

**To Apply:** Applications and links to Work samples must be submitted electronically. All materials must be received on April 30, 2017 by 11:59 pm

#### **About Work Samples**

---

Please submit your Work Samples electronically by sending us an online link (Dropbox, Vimeo, Google Drive or YouTube are accepted) with any necessary password information. All materials must be **RECEIVED by April 18<sup>th</sup> 2017**

- **The work sample** should have 3-minute excerpts from 3 separate pieces, clearly marked with your name. (See below for important work sample information.) Please be sure to include the work sample information page 2 of the application form.
- Check to make sure your link and passwords work

Do NOT send highly edited promotional material or spliced samples. We are interested in three contiguous minutes of sustained choreography from 3 different pieces, not “highlights.” Over-edited samples will be disqualified.

- Send excerpts from three different pieces of choreography to demonstrate your range.

Solo material is acceptable for one, but not more of your work samples.

- Your samples must be of work choreographed by you.
- Be sure to use quality samples
- Do not submit dark work samples or samples with poor visibility.
